#### **General Conditions**

##### **01. Invitation for Bids**

The Chairman, Department Procurement Committee, Development Lotteries Board invites sealed bids up to **2.30 p.m. on 14.10.2022** For “Fabricating, Supplying and Delivering of Steel Lottery Sales outlets”.

##### **02. Issuing of Bidding Documents**

Bidding document and specifications can be inspected and obtained from the Head office of the Development Lotteries Board at No. 356, Dr. Colvin R. De Silva Mawatha, Union Place, Colombo 02, between 9.00 a.m. to 3.00 p.m. from Monday to Friday, other than on Public Holidays, upon a non-refundable payment of **Rs. 4,600.00** (Four thousand six hundred)

##### **03. Eligibility Criteria**

- a) Bidder should have a valid business registration
- b) The Bidder should have minimum of 03 year experience in designing, fabricating and supplying of iron outlets, trade stalls. (Similar field)
- c) Bidder should have minimum one similar nature works experience, value not less than 17.5 million during the last 03 years.
- d) Having experiences in designing, fabricating and supplying of steel sales outlets, trade stalls and as well as tenderers who have workshop facilities, qualified personnel and trained staff, tools and equipment etc.,
- e) Bidder must submit documentary evidence to prove his/her ability to carry out the contract. This should include past experience, clientele, workshop facilities, qualified personnel and trained staff, tools and equipment, financial position and other relevant information to complete the tender successfully.

(Documentary evidence should be furnished if not bids will be rejected)

##### **04. Specification and Services required**

Specifications and services requirement are given in as per the annexure “c”.

## 05. Bid Security

- I. (a) Bids should be submitted in duplicate. The bid must be accompanied by a BID Security for amounting **Rs.350,000.00** payable on demand addressed to the Chairman, Development Lotteries Board, in Sri Lanka Rupees valid for a period of One Hundred & Eighteen (118) days (**up to 09.02.2023**) from the date of closing of bids. The bid bond should be furnished and submitted along with the Bid.

(b) The bid bond required shall be furnished by the bidders in the form “E” annexed by a recognized commercial bank operating in Sri Lanka approved by the Central bank of Sri Lanka.

Bidders which are not secured with the bid bond pursuant to clause (b) above and not submitted in the format given in form “E” shall be rejected.

- II. Each page of the bid document should be signed by the bidder or duly authorized officer and enclosed in a sealed cover (together with a signed copy of the conditions of the bid) marked “**Bid for Fabricating, Supplying and Delivering of 300 No’s Steel Lottery Sales Outlets**” on the top of the left-hand corner and addressed to the Chairman, Department Procurement Committee, Development Lotteries Board, No. 356, Dr. Colvin R. De Silva Mawatha, Union Place, Colombo 02. The original and copy should be submitted separately and have to be clearly marked on covers.

Bidder’s address should be indicated on the bottom of the left corner of the envelope.

## 06. Submission of Bid

Bids shall be made in accordance with the bid documents, consisting of the following documents:

- b) Specimen Form of Performance Bond ( Annex “F”)
- c) Bid Form (Annex “A”)
- d) Price Schedule (Annex “D”)
- e) Technical specifications (Annex “C”)
- f) The bidder should submit documentary evidence of experience in required by clause 3 above. (Annex –B)

## 07. Language and Bid

All correspondence and documents relating to the bid shall be in ENGLISH language.

## 08. Closing Date

Sealed bids should be sent by post under registered cover, so as to reach the chairman, Minor, Procurement Committee, Development Lotteries Board, No. 356, Dr. Colvin R. De Silva Mawatha, Union Place, Colombo 02 not later than 2.30 p.m. on 14.10.2022 Bidders can deliver their bids by hand to the same address mentioned above not later than 2.30 p.m. on 14.10.2022 Original Bid and the duplicate are not received by the specified time on the due date will be rejected.

## **09. Closing/ Opening Bids**

I. Bids will be closed at 2.30 p.m. on 14.10.2022 and opened immediately thereafter at the office of Development Lotteries Board, No. 356, Dr. Colvin R. De Silva Mawatha, Union Place, Colombo 02.

II. Bidder or his/her duly authorized representatives may be present at the time of opening bids.

## **10. Validity of Bid**

Bids should be valid for period of Ninety (90) DAYS (Up to 12.01.2023 ) from the date of closing of the bid.

## **11. Bid Prices**

- I. Prices should be quoted in Sri Lankan rupees details given in the annexure “D”
- II. If the bid reveal that there are arithmetical or other errors in the rates or amounts quoted in the price schedule submitted with such bid, they should be corrected, and where there is a discrepancy in the amounts in figures and in words, in such an event amount inward will be considered.
- III. Bidder should quote the work stipulated in the bidding document per unit cost ( per outlet)
- IV. If any discounts applicable please indicate separately in the price schedule.

## **12. Right to Accept or Reject**

The Department Procurement Committee reserves the right to accept or reject the bid or any part of it without assigning any reasons. Department Procurement Committee is not bound to accept the lowest bid. DLB has right to award this contract to the single supplier or more than one suppliers.

## **13. Notice of Acceptance of Bid**

Acceptance of the bid will be communicated by fax and confirmed in writing by registered post to the successful bidder. Any changes of the address of the bidder should therefore be promptly notified to the Chairman, Development Lotteries Board, No. 356, Dr. Colvin R. De Silva Mawatha, Union Place, Colombo 02.

## **14. Performance Bond**

- I.(a) The bidder shall at his own expense deposit with the chairman, Development Lotteries Board within ten (10) working days of the date of notice of award of the bid a performance bond payable on demand in terms of annex “F” attached in favor of the Development Lotteries Board in the form of a performance guarantee from a reputed commercial bank in the country of the supplier with a confirmation by a bank in Sri Lanka approved by Central Bank of Sri Lanka the performance bond for an amount equivalent to ten percent (10%) of the contract price, for the due and punctual performance and fulfillment of the contract.

(b) The performance bond will be discharged by the Development Lotteries Board upon being satisfied that there has been due performance of the obligation of the bidder.

(c) The performance bond shall be valid for the full contract period and any extensions thereafter.

(d) The performance bond will be discharged 6 months pursuant of the obligation due to the satisfaction of the Chairman of the Development Lotteries Board. No interest will be paid for the performance bond.

**15.** The bidder is at liberty to submit any additional information, details of features which may be considered desirable together with cost thereon and the same shall be sent out with a separate covering letter which shall accompany the bid. The Department Procurement Committee reserves the right to accept Or reject such additional features at its discretion.

#### **16. Contract Period**

Contract period for Completion of the order is 04 months for the signing of agreement. DLB has right to minimize the order Qty considering the requirement.

#### **17. Delivery of Outlets / Sample inspection**

a) All outlets should be supplied within 04 months period from the date of awarding. Selected supplier should be Delivered Ordered Outlets within 07 days from the delivery location Notifications by DLB.

b) Selected Suppliers should be submitted delivery program within 10 days from the Letter of Award. Partial delivery allowed.

c) Sample will be checked while the manufacturing outlets and prior to the delivery.

d) In the case of any delay, the Chairman, Development Lotteries Board shall have the option of either granting an extension or terminating the contract and collecting the performance bond without prejudice to any other claims that may be lodged in this regard.

#### **18. Sample Evaluation.**

The successful bidder should supply a sample/ model outlet as per the specifications to the Development Lotteries Board for evaluation, within 07 days after informing in writing. If fail to submit the sample, bids will be rejected.

#### **19. Force Majeure**

In the event of War or disturbances, strike or pestilence or epidemical sickness or earthquake, fire storms or flood or other hindrance affecting the contractor being the act of god or beyond the control of the parties the terms or contract shall be subject to such modification as the circumstances may warrant.

## **20. Governing Law**

The bids and any contract resulting there from shall be governed by and construed according to the Law of Sri Lanka.

## **21. Miscellaneous**

- a) Bidders must acquaint themselves fully with the conditions of the bid. No plea of lack of information or insufficient information will be entertained at any time.

## **22. Individuals not Personally Liable**

No member or officer or an employee of the Development Lotteries Board shall be in anyway personally bound or liable for the acts or obligations of the bidder under the contract or answerable for any default or omission of the successful bidder in the observance or performance of any of the acts, matters or things which are herein contained.

## **23. Arbitration**

- a. All disputes arise in connection with the present contract shall be finally settled in accordance with the provisions of arbitration Act No 11 of 1995.
- b. Performance of the contract shall continue during arbitration proceedings.
- c. All proceedings and hearings by arbitrators shall be held in Sri Lanka.

## **24. Termination Clause**

The Chairman of Development Lotteries Board has the right to terminate the agreement; in the event of the services do not meet the requirements specified in the bidding document.

## **25. Notice**

- a. Any notice given by one party to the other pursuant to this contract shall be sent in writing or by fax and confirmed in writing to the address specified in the documents.
- b. A notice shall be effective when delivered or on the notice's effective date, whichever is later.

**26.** The procurement committee shall not be liable or pay for any expenses or losses, which may be incurred by any bidder in the preparation or otherwise of this bid.

## **27. Payment terms**

**Payments will be made as follows**

### **(a) Advance .Payment :-**

20% of contract value shall be related as an advance payment on submission an advance payment guarantee.

**(b) Final Payments** :-Payments Will be made within 30 days from the completion of the project . Final payments will be released after submitting following documents,

- Tax Invoice
- Delivery note with GRN.
- Based on the Job completion report submitted by the nominated technical representative of DLB.

**(c) Retention money:-**

05% of the work done value will be deducted from the final payment as the retention money. Retention will be released after 06 months of the delivery date.

**(d) Taxes and Duties**

The supplier is responsible for all taxes, stamp duties, license fee and other levies related to obtaining the permission for the hoardings. Transport and installation cost must be included to the estimate.

**28. Warranty (Break Down, Technical Faults, etc.)**

- The outlet supplied shall be covered by comprehensive parts, repairs and labor replacement warranty for 12 calendar months from the date of delivery the outlets.
- In case of breakdown or technical error occurred with no involvement of the dealer or dealer assistant, the supplier shall repair or re-fabricate the outlet free of charge within one week from the date of informed.

If not ,a sum of a Rs. 5,000/= as a liquidated damage has to be paid per day to the Development Lotteries Board by the supplier and DLB has the right to claim that amount from performance bond submitted by the bidder.

This agreement is made and entered into at Colombo in the Democratic Socialist Republic of Sri Lanka on this ..... De Silva Mawatha, Union Place, Colombo 02, Sri Lanka. (Hereinafter called and referred to as "the Board" which term or expression as herein used shall as and where the context so requires or admits of constructions, mean and include the said Development Lotteries Board, its successors and permitted assigns) of the one part and ..... (Name of contractor) ..... having its registered office at .....

(herein after called and referred to as "The Contractor" which term or expression as herein used shall where the context so requires or admits of construction mean and include the said contractor its successors and permitted assigns) of the other part.

Whereas the board is desirous that certain goods and services should be provided by the contractor, viz. designing, developing, printing pasting of stickers and producing and installing of hoardings has accepted the tender made by the contractor, for the provision of those goods and services. (The said accepted tender is annexed hereto and shall part and parcel of this agreement)

### NOW THIS AGREEMENT WITNESSES AS FOLLOWS

1. In this agreement words and expressions shall have the same meaning as are respectively assigned to them in the conditions of tender referred to.
2. Agreement will be valid for 04 months from the date of signing.
3. This agreement shall come in the operation only upon furnishing the performance bond and the security deposit by the contractor and signing of this agreement by both parties.
4. The following documents shall be deemed to form and be read and construed as part and parcel of this agreement. Viz.
  - a. General Conditions of Bid.
  - b. Technical Specifications.
  - c. Price Schedule (Annex "D").
  - d. All other relevant documents in the Tender documents.
5. In consideration of the payments to be made by the board to the contractor as hereinafter mentioned, the contractor, hereby covenants with the board to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the agreement.
6. The board hereby covenants to pay the contractor, in consideration of the provisions of the goods and services and the remedying of defects herein, the contract price or such other sum as may become payable under the provisions of the agreement at the times and in the manner prescribed by the agreement.
7. Breakdown, Technical Faults, etc.
  - In case of any breakdown or technical error occurred with no involvement of the dealer or dealer assistant, the supplier shall repair or re-fabricate the outlet free of charge within once informed in writing or any other method of communication by way of fax or telephone by the Development Lotteries Board.
  - If not a sum of Rs.5,000/= liquidated damages has to be paid per day by the contractor, to the Development Lotteries Board and Development Lotteries Board has the right to claim that amount from the performance bond submitted by the contractor.
  - This agreement shall be governed by the constructed in accordance with laws in Sri Lanka.
  - Constructor under any circumstances is not entitled to claim and demand any compensation from the board for the expenses incurred by the contractor or any damages caused to a third party.

- The contractor shall keep the board at all times freed and indemnified from all prosecutions or fines which may be instituted or imposed in consequence of any breach or non-performance of any laws or by laws of the local or other authorities.
- In case of violence due to the war, civil commotion or of fire explosion, storm, tempest flood, inevitable accidents or other irresistible force, causing damage to the demised premises the contractor shall repair it immediately at the contractors cost and expenses.
- All notices and communication required to be given hereunder shall be deemed sufficient and as duly given if addressed and sent by registered post or fax to their respective registered offices.
- In the event contractor fails to comply with the terms and conditions to this agreement the Chairman of Development Lotteries Board shall have the power to terminate this agreement given proper notice to the contractor.

8. This agreement constitutes the entire understanding between parties as to the subject matter thereof and may be amended or modified only by an agreement in writing signed by both parties.
