The Standard High Level Procurement Committee(SHLPC) on behalf of the Development Lotteries Board invites sealed bids for the Invitation to Bids for Designing, Developing, Printing, and Supplying of Draw Lottery Tickets for the Period of one year (Lagna Wasanawa, Kapruka, Ada Kotipathy, Super Ball, Sasiri, Shanida, Supiri Dhana Sampatha, New Draw Lottery Ticket No 1 & New Draw Lottery No 2) draw lottery tickets from eligible and qualified local bidders for the period of one year. To become eligible for bid, bidders should meet the minimum requirements stipulated on eligibility criteria in the bidding document and also should be a registered company in the variable data printing field and shall not be backlisted according to the procurement guideline or backlisting process in progress by the procurement entity.

02. Bidding will be conducted through the National Competitive Bidding Procedure. (NCB)
03. Irrespective of having quoted the lowest rate for all or several lottery brands maximum lottery brands will be awarded to one bidder not exceeding 70% of the total tickets requirement of the DLB on considering the printing capacity of the bidder, Evaluation will be done on sequencing of Lagna Wasanawa, Kapruka, Ada Kotipathy, Super Ball, Sasiri, Shanida, Supiri Dhana Sampatha, New Draw Lottery 1 & New Draw lottery No 2. Minimum 02 No of suppliers will be selected from this procurement.
04. A set of Bidding document can be inspected at the Procurement Division of Development Lotteries Board, No.356, Dr. Colvin R. De Silva Mawatha, Colombo 02 on free of charges during the **07.04.2025 to 07.05.2025** between **9.00 a.m. to 3.00 p.m.**
05. Bidding documents may be purchased from the Procurement division of the Development Lotteries Board at No 356, Dr Colvin R de Silva Mawatha, Colombo 2, from **07.04.2025 to 07.05.2025 between 09.00 a m to 3.00 p.m.** from Monday to Friday (other than on public holidays) subject to the payment of **Rs.60,000.00 (With Taxes)** in cash as non-refundable document fee on submission of the written request on a business letter head, addressed to the Chairman, Development Lotteries Board, No.356, Dr Colvin R de Silva Mawatha, Colombo 2.
06. All bids must be accompanied by a Bid Security amounting to values specified in the ITB 20.1 of the BDS for the period of 147 days furnished from a commercial bank operating in Sri Lanka registered with Central Bank of Sri Lanka or in the form of a Bank Guarantee to the Chairman, Development Lotteries Board at No 356, Dr Colvin R de Silva Mawatha, Colombo 2.
07. All the bidders should have the contract registration certificate obtained according to the “Public Contract Act No.3 of 1987” for the particular bid. If not submitted treated as rejection of bid.
08. Pre-bid meeting is scheduled at **2.30 p.m on 23.04.2025** at the Development Lotteries Board, No 356, Dr Colvin R de Silva Mawatha, Colombo 2
09. Bidders should furnish all the detailed information as required in the bid document.
10. Sealed bids in duplicate under registered cover should be posted to reach “Chairman, The standard High Level Procurement Committee(SHLPC), C/o Development Lotteries Board at No 356, Dr Colvin R de Silva Mawatha, Colombo 2” or deposited in the box provided in the Procurement Division for this purpose at the above address on or before **2.30p.m on 08.05.2025** The words “Bid for the Designing, Developing, Printing and Supplying of Draw Lottery tickets to the Development Lotteries Board ” shall be written on top left-hand corner of the envelope. Also, it should be indicated the Bid name and Bid No.
11. Bids will be closed at 2.30 p.m. on **08.05.2025** at the procurement division of DLB. Bids will be opened immediately after the closure of the bid submission time. Bidders or their duly authorized representatives are requested to be present at the time of opening of bids. Late bids will be rejected, unopened.
12. The Standard High Level Procurement Committee(SHLPC) reserves its sole right to accept or reject any or all the offers or any part thereof without assigning any reason therefore and or call for additional information where necessary, as per the procurement guidelines.

Instruction To Bidders (ITB)

ITB shall be read in conjunction with the Bidding Data Sheet (BDS), which shall take precedence over ITB.

General

1. Scope of Bid

- 1.1 The Purchaser indicated in the **Bidding Data Sheet (BDS)**, Issues these Bidding Documents for the supply of Goods and Related Services incidental thereto as specified, Schedule of Requirements. The name and identification number of this procurement are specified in the BDS. The name, identification, and number of lots (individual contracts), if any, are provide in the BDS.
- 1.2 Throughout these Bidding Documents:
 - (a) The term “in writing” means communicated in written form by mail (other than electronic mail) or hand delivered with proof of receipt.
 - (b) If the context so requires, “singular” means “plural” and vice versa; and
 - (c) “day” means calendar day.

2. Source of Funds

- 2.1 Payments under this contract will be financed by the Sources specified in the BDS.

3. Ethics, Fraud and Corruption

- 3.1 The attention of the bidders is drawn to the following guidelines of the Procurement Guidelines published by Department of Public Finance.

Parties associated with Procurement Actions, namely, suppliers/contractors and officials shall ensure that they maintain strict confidentiality throughout the process;

Officials shall refrain from receiving any personal gain from any Procurement Action. No gifts or inducement shall be accepted. Suppliers/contractors are liable to be disqualified from the bidding process if found offering any gift or inducement which may have an effect of influencing a decision or impairing the objectivity of an official.

- 3.2 The Purchaser requires the bidders, suppliers, contractors, and consultants to observe the highest standard of ethics during the procurement and execution of such contracts. In pursuit of this policy:

- (a) “corrupt practice” means the offering, giving, receiving, or soliciting, directly or indirectly of anything of value to influence the action of a public official in the procurement process or in contract execution;
- (b) “Fraudulent proactive” means a misrepresentation or omission of facts in order to influence a procurement process or the execution of a contract;
- (c) “collusive practice” means a scheme or arrangement between two or more bidders, with or without the knowledge of the Purchaser to establish bid prices at artificial, noncompetitive levels; and
- (d) “coercive practice” means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the procurement process or affect the execution of a contract.

3.3 If the Purchaser found any unethical practices as stipulated under ITB Clause 3.2, the Purchaser will reject a bid, if it is found that a Bidder directly or through an agent, engaged in corrupt, fraudulent, collusive or coercive practices in competing for the Contract in question.

4. Eligible Bidders

- 4.1 All bidders shall possess legal rights to supply the Goods Under this contract.
- 4.2 A Bidder shall not have a conflict of interest. All bidders found to have conflict of interest shall be disqualified. Bidders may be considered to have a conflict of interest with one or more parties in this bidding process, if they:
 - (a) Are or have been associated in the past, with a firm or any of its affiliates which have been engaged by the Purchaser to provide consulting services for the preparation of the design, specifications, and other documents to be used for the procurement of the goods to be purchased under these Bidding Documents; or
 - (b) Submit more than one bid in this bidding process. However, this does not limit the participation of subcontractors in more than one bid.
- 4.3 A Bidder that is under a declaration of ineligibility by the Department of Public Finance (DPF), at the date of

submission of bids or at the date of contract award, shall be disqualified. The list of debarred firms is available at the website of Department of Public Finance (www.pfd.gov.lk)

4.4 Foreign Bidder may submit a bid only if so stated in the BDS.

5. Eligible Goods and Related Services

5.1 All goods supplied under this contract shall be complied With applicable standards stipulated by the Sri Lanka Standards Institute (SLSI). In the absence of such standards, the Goods supplied shall be complied to other internationally accepted standards.

6. Sections of Bidding Documents

6.1 The Bidding Documents consist all the sections indicated below, and should be read in conjunction with any addendum issued in accordance with ITB Clause 8.

- Invitation for Bid
- Instructions to Bidders (ITB)
- Bidding Data Sheet (BDS)
- Eligibility Criteria
- Special Conditions
- General Specifications
- Bidding Forms
- Technical Specifications
- Conditions of Contract (CC)
- Contract Forms
- Insurance
- Machinery, Technical & Staff Details
- Affidavit document
- Financial capacity confirmation

6.2 The Bidder is expected to examine all instructions, forms, terms, and specifications in the Bidding Documents. Failure to furnish all information or documentation required by the Bidding Documents my result in the rejection of the bid.

7. Clarification of Bidding Documents

7.1 A Prospective Bidder requiring any clarification of the Bidding Documents including the restrictiveness of specifications shall contact the Purchaser in writing at the Purchaser's address specified in the BDS. The Purchaser will respond in writing to any request for clarification, provided that such request is received not later than seven (07) days prior to the deadline for submission of bids. The Purchaser shall forward copies of its response to all those who have purchased the Bidding Documents, including a description of the inquiry but without identifying its source. Should the

Purchaser deem it necessary to amend the Bidding documents as a result of a clarification, it shall do so following the procedure under ITB Clause 8.0

8. Amendment of Bidding Documents

- 8.1 At any time prior to the deadline for submission of bids, the Purchaser may amend the Bidding Documents by issuing addendum.
- 8.2 Any addendum issued shall be part of the Bidding Documents and shall be communicated in writing to all who have purchased the Bidding Documents.
- 8.3 To give prospective Bidders reasonable time in which to take an addendum into account in preparing their bids, the Purchaser may, at its discretion, extend the deadline for the submission of bids, pursuant to ITB Sub-Clause 23.2.

Preparation of Bids

9. Cost of Bidding

- 9.1 The Bidder shall bear all costs associated with the preparation and submission of its bid, and the Purchaser shall not be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

10. Language of Bid

- 10.1 The Bid, as well as all correspondence and Documents relating to the Bid (including supporting documents and printed literature) exchanged by the Bidder and the Purchaser, shall be written in English Language.

11. Documents Comprising the Bid

- 11.1 The Bid shall comprise the following:
 - (a) Bid Submission Form and the applicable Price Schedules, in accordance with ITB Clauses 12, 14 and 15.
 - (b) Bid Security or Bid-Securing Declaration, in accordance with ITB Clause 20;
 - (c) Documentary evidence in accordance with ITB Clauses 18 and 29, that the Goods and Related Services conform to the Bidding Documents;
 - (d) Documentary evidence in accordance with ITB Clause 18 establishing the Bidder's qualifications to perform the contract if its bid is accepted; and
 - (e) Any other document required in the BDS.

12. Bid Submission Form and Price Schedules

12.1 The Bidder shall submit the Bid Submission Form using the form furnished in Bidding Forms. This form must be completed without any alterations to its format, and no substitutes shall be accepted. All blank spaces shall be filled in with the information requested.

13. Alternative Bids

13.1 Alternative bids shall not be considered.

14. Bid Prices and Discounts

14.1 The Bidder shall indicate on the Price Schedule the unit Prices and total bid prices of the goods it proposes to supply under the Contract.

14.2 Any discount offered against any single item in the prices schedule shall be included in the unit price of the item. However, a Bidder wishes to offer discount as a lot the bidder may do so by indicating such amounts appropriately.

14.3 If so indicated in ITB Sub-Clause 1.1, bids are being invited for individual contract (lots) or for any combination of contracts (packages). Unless otherwise indicated in the BDS, prices quoted shall correspond to 100% of the items specified for each lot and to 100% of the quantities specified for each item of a lot. Bidders wishing to offer any price reduction (discount) for the award of more than one Contract shall specify the applicable price reduction separately.

14.4 (i) Prices indicated on the Price Schedule shall include all duties and sales and other taxes already paid or payable by the Supplier:

(a) On components and raw material used in the manufacture or assembly of goods quoted; or

(b) On the previously imported goods of foreign origin.

(ii) However, VAT shall not be included in the price but shall be indicated separately.

(iii) the price for inland transportation, insurance and other related services to deliver the goods to their final destination;

(iv) the price of other incidental services

14.5 The Prices quoted by the Bidder shall be fixed during the Bidder's performance of the Contract and not subject to variation on any account. A bid submitted with an adjustable

price quotation will be treated as non-responsive and rejected, pursuant to ITB Clause 31.

14.6 All lots, if any, and items must be listed and priced separately in the Price Schedules. If a Price Schedule shows items listed but not priced, their prices shall be assumed to be included in the prices of other items.

15. Currencies of Bid

15.1 Unless otherwise stated in Bidding Data Sheet, the Bidder Shall quote in Sri Lankan Rupees and payment shall be payable only in Sri Lankan Rupees.

16. Documents Establishing the Bidder

16.1 To establish their eligibility in accordance with ITB Clause 4, Bidders shall complete the Bid Submission Form, included in Eligibility of the Bidding Forms.

17. Documents Establishing the conformity of the Goods and related services

17.1 To establish the conformity of the Goods and Related Services to the Bidding Documents, the Bidder shall furnish as part of its Bid the documentary evidence that the Goods and conform to the technical specifications and standards related specified in Schedule of Requirements.

17.2 The documentary evidence may be in the form of literature, drawings or data, and shall consist of a detailed item by item description (given in Technical Specifications) of the essential technical and performance characteristics of the Goods and Related Services, demonstrating substantial responsiveness of the Goods and Related Services to the technical specification, and if applicable, a statement of deviations and exceptions to the provisions of the Schedule of Requirements.

17.3 The Bidder shall also furnish a list giving full particulars, including quantities, available sources and current prices of spare parts, special tool, etc., necessary for the proper and continuing functioning of the Goods during the period if specified in the BDS following commencement of the use of the goods by the Purchaser.

18. Documents establishing the qualifications of the bidder

18.1 The documentary evidence of the Bidder's qualifications to perform the contract if its bid is accepted shall establish to the Purchaser's satisfaction:

(a) A Bidder that does not manufacture or produce the Goods it offers to supply shall submit the Manufacturer's Authorization using the form included in Bidding Forms to demonstrate that it has been duly authorized by the

manufacturer or producer of the Goods to supply these Goods;

- (b) that, if required in the BDS, in case of Bidder not doing business within Sri Lanka, the Bidder is or will be (if awarded the contract) represented by an Agent in Sri Lanka equipped and able to carry out the Supplier's maintenance, repair and spare parts stocking obligations prescribed in the Conditions of Contract and/or Technical Specifications; and
- (c) That the Bidder meets each of the qualification criteria specified in Evaluation and Qualification Criteria.

19. Period of Validity of Bids

- 19.1 Bids shall remain valid until the date specified in the BDS. A Bid valid for a shorter date shall be rejected by the Purchaser as non responsive.
- 19.2 In exceptional circumstances, prior to the expiration of the bid validity date, the Purchaser may request bidders to extend the period of validity of their bids. The request and the responses shall be made in writing. If a Bid Security is requested in accordance with ITB Clause 20, it shall also be extended for a corresponding period. A Bidder may refuse the request without forfeiting its Bid Security. A Bidder granting the request shall not be required or permitted to modify its bid.

20. Bid Security

- 20.1 The Bid Security shall be in the amount specified in the BDS and denominated in Sri Lankan Rupees, and shall:
 - (a) at the bidder's option, be in the form of unconditional bank guarantee from a bank registered under the Central Bank of Sri Lanka.
 - (b) Be issued by an institution acceptable to Purchaser. The acceptable institutes are published in the Department of Public Finance. (www.pfd.gov.lk)
 - (c) be substantially in accordance with the form included in Bidding Forms;
 - (d) Be payable promptly upon written demand by the Purchaser in case the conditions listed in ITB clause 20.4 are invoked.

- (e) be submitted in its original form; copies will not be accepted;
 - (f) remain valid for the period specified in the BDS.
- 20.2 Any bid not accompanied by substantially responsive Bid Security or Bid Securing Declaration in accordance with ITB Sub-Clause 20.1, may be rejected by the Purchaser as non-responsive.
- 20.3 The Bid Security of unsuccessful Bidders shall be returned as promptly as possible upon the successful Bidder's furnishing of the Performance Security pursuant to ITB Clause 42.
- 20.4 The Bid Security may be forfeited or the Bid Securing Declaration executed:
- (a) if a Bidder withdraws its bid during the period of bid validity specified by the Bidder on the Bid submission Form, except as provided in ITB Sub-clause 19.2; or
 - (b) if a Bidder does not agreeing to correction of arithmetical errors in pursuant to ITB Sub-Clause 30.3
 - (c) if the successful Bidder fails to :
 - (i) sign the Contract in accordance with ITB Clause 41;
 - (ii) furnish a Performance Security in accordance with ITB Clause 42.

21 Format and Signing of Bid

- 21.1 The Bidder shall prepare one original of the documents comprising the bid as described in ITB Clause 11 and clearly mark it as "ORIGINAL." In addition, the Bidder shall submit a copy of the bid and clearly mark it as "COPY". In the event of any discrepancy between the original and the copy, the original shall prevail.
- 21.2 The original and the Copy of the bid shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the Bidder.
- 21.3 Any interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by the person signing the Bid.

Submission and Opening of Bids

22 Submission, Sealing and Marking of Bids

- 22.1 Bidders may always submit their bids by mail or by hand.
- (a) Bidders submitting bids by mail or by hand, shall enclose the original and the copy of the Bid in separate sealed envelopes, duly marking the envelopes as “ORIGINAL” and “COPY”. These envelopes containing the original and the copy shall then be enclosed in one single envelope.
- 22.2 The inner and outer envelopes shall:
- (a) bear the name and address of the Bidder;
- (b) be addressed to the Purchaser in accordance with ITB Sub-Clause 23.1;
- (c) bear the specific identification of this bidding process as indicated in the BDS; and
- (d) bear a warning not to open before the time and date for bid opening, in accordance with ITB Sub-Clause 26.1.

If all envelopes are not sealed and marked as required, the Purchaser will assume no responsibility for the misplacement or premature opening of the bid.

23 Deadline for Submission of Bids

- 23.1 Bids must be received by the Purchaser at the address and not later than the date and time specified in the BDS.
- 23.2 The Purchaser may at its discretion, extend the deadline for the submission of bids by amending the Bidding Document in accordance with ITB Clause 8, in which case all rights and obligations of the Purchaser and Bidders previously subject to the deadline shall thereafter be subject to the deadline as extended.

24 Late Bids

- 24.1 The Purchaser shall not consider any bid that arrives after the deadline for submission of bids, in accordance with ITB Clause. Any bid received by the Purchaser after the deadline for submission of bids shall be declared late, rejected, and returned unopened to the Bidder.

25 Withdrawal and Modification of Bids

- 25.1 A Bidder may withdraw, or modify its Bid after it has been Submitted by sending a written notice in accordance with ITB Clause 22, duly signed by an authorized representative, and shall include a copy of the authorization in accordance with ITB Sub-Clause 21.2, (except that no copies of the withdrawal Notice are required). The corresponding substitution or Modification of the bid must accompany the respective written notice, all notices must be:
- (a) submitted in accordance with ITB Clauses 21 and 22 (except that withdrawal notices do not require copies), and in addition, the respective envelopes shall be clearly marked “WITHDRAWAL”, or “MODIFICATION”; and
 - (b) Received by the Purchaser prior to the deadline prescribed for submission of bids, in accordance with ITB Clause 23.
- 25.2 Bids requested to be withdrawn in accordance with ITB Sub-Clause 25.1 shall be returned to the Bidders only upon notification of contract award to the successfully bidder in accordance with sub clause 40.1.
- 25.3 No bid may be withdrawn, substituted, or modified in the interval between the deadline for submission of bids and the expiration of the period of bid validity specified by the Bidder on the Bid Submission Form or any extension thereof

26 Bid Opening

- 26.1 The Purchaser shall conduct the bid opening in public at the address, date and time specified in the BDS. Bidder or his authorized representative can be participated at the time of the bid opening.
- 26.2 First, envelopes marked “**WITHDRAWAL**” shall be opened and read out and the envelope with the corresponding bid may be opened at the discretion of the Purchaser. No bid withdrawal shall be permitted unless the corresponding withdrawal notice contain a valid authorization to request the withdrawal and is read out at bid opening. Envelopes marked “**MODIFICATION**” shall be opened and read out with the corresponding Bid. No Bid modification shall be permitted unless the corresponding modification notice contains a valid authorization to request the modification and is read out at

Bid opening. Only envelopes that are opened and read out at Bid opening shall be considered further.

- 26.3 All other envelopes shall be opened one at a time, reading out the name of the Bidder and whether there is a modification; the Bid Prices, including any discounts and alternative offers; the presence of a Bid Security or Bid Securing Declaration, if required; and any other details as the Purchaser may consider appropriate. Only discounts and alternative offers read out at Bid opening shall be considered for valuation. No Bid shall be rejected at Bid opening except for late bids, in accordance with ITB Sub-Clause 24.1.
- 26.4 The Purchaser shall prepare a record of the Bid opening that shall include, as minimum: the name of the Bidder and whether there is a withdrawal, or modification; the Bid Price, per lot if applicable, including any discounts, and the presence or absence of a Bid Security or Bid-Securing Declaration. The Bids that were opened shall be resealed in separate envelopes, promptly after the bid opening. The Bidder's representatives who are present shall be requested to sign the attendance sheet. A copy of the record shall be distributed to all Bidders who submitted bids in time.

Evaluation and Comparison of Bids

27 Confidentiality

- 27.1 Information relating to the examination, evaluation, comparison, and post-qualification (if applicable) of bids, and recommendation of contract award, shall not be disclosed to bidders or any other persons not officially concerned with such process until publication of the Contract Award.
- 27.2 Any effort by a Bidder to influence the Purchaser in the Examination, evaluation, comparison and post-qualification of the bids or contract award decisions may result in the rejection of its Bid.
- 27.3 Notwithstanding ITB Sub-Clause 27.2, if any Bidder wishes to contact the Purchaser on any matter related to the bidding process, from the time of bid opening to the time of Contract Award, it should do so in writing.

28 Clarification of Bids

- 28.1 To assist in the examination, evaluation, comparison and post-qualification of the bids, the Purchaser may, at its discretion, request any Bidder for a clarification of its Bid. Any clarification submitted by a Bidder in respect to its Bid

and that is not in response to a request by the Purchaser shall not be considered for purpose of evaluation. The Purchaser's request for clarification and the response shall be in writing. No change in the prices or substance of the Bid shall be sought, offered or permitted, except to confirm the correction of arithmetic errors discovered by the Purchaser in the evaluation of the bids, in accordance with ITB Clause 30.

29 Responsiveness of Bids

- 29.1 The Purchaser's determination of a bid's responsiveness is to be based on the contents of the bid itself.
- 29.2 A substantially responsive Bid is one that conforms to all the terms, conditions and specifications of the Bidding Documents without material deviation, reservation or omission. A material deviation, reservation or omission is one that;
- (a) affects in any substantial way the scope, quality or performance of the Goods and Related Services specified in the Contract; or
 - (b) limits in any substantial way, inconsistent with the Bidding Documents, the Purchaser's rights or the Bidder's obligations under the Contract; or
 - (c) if rectified would unfairly affect the competitive position of other bidders presenting substantially responsive bids.
- 29.3 If a bid is not substantially responsive to the Bidding Documents, it shall be rejected by the Purchaser and may not subsequently be made responsive by the Bidder by correction of the material deviation, reservation or omission.

30 Nonconformities, Errors and Omissions

- 30.1 Provided that a Bid is substantially responsive, the Purchaser may waive any non-conformities or omissions in the Bid that do not constitute a material deviation.
- 30.2 Provided that the Bid is substantially responsive, the Purchaser may request that the Bidder submit the necessary information or documentation, within a reasonable period of time, to rectify non material nonconformities or omissions in the bid related to documentation requirements. Such omission shall not be related to any aspect of the price of the Bid. Failure of the Bidder to comply with the request may result in the rejection of its Bid.
- 30.3 Provided that the Bid is substantially responsive, the

purchaser shall correct arithmetical errors on the following basis:

- (a) if there is a discrepancy between the unit price and the line item total that is obtained by multiplying the unit price by the quantity, the unit price shall prevail and the line item total shall be corrected, unless in the opinion of the Purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the line item total as quoted shall govern and the unit price shall be corrected;
- (b) if there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
- (c) if there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (a) and (b) above.

30.4 If the Bidder that submitted the lowest evaluated Bid does Not accept the correction of errors, its Bid shall be disqualified and its Bid Security shall be forfeited or its Bid-Securing Declaration shall be executed.

31 Preliminary Examination of Bids

31.1 The Purchaser shall examine the bids to confirm that all documents and technical documentation requested in ITB Clause 11 have been provided and to determine the completeness of each document submitted.

31.2 The Purchaser shall confirm that the following documents and information have been provided in the Bid. If any of these documents or information is missing, the Bid shall be rejected.

- (a) Bid Submission Form, in accordance with ITB Sub-Clause 12.1;
- (b) Price Schedules, in accordance with ITB Sub-Clause 12;
- (c) Bid Security or Bid Securing Declaration, in accordance with ITB Clause 20.

32 Examination of Terms and Conditions; Technical Evaluation

32.1 The Purchaser shall examine the Bid to confirm that all terms

and conditions specified in the CC and the Contract Data have been accepted by the Bidder without any material deviation or reservation.

32.2 The Purchaser shall evaluate the technical aspects of the bid submitted in accordance with ITB Clause 17, to confirm that all specified in Schedule of Requirements of the Bidding Documents have been met without any material deviation or reservation.

32.3 If, after the examination of the terms and conditions and the technical evaluation, the Purchaser determines that the Bid is not substantially responsive in accordance with ITB Clause 29, the Purchaser shall reject the Bid.

33 Contract period/ Commencement of the contract

33.1 The contract will be awarded for a period of 12 months ,where as if the bidder is willing to continue his/ her service for a further 12 months for the same rate that has to be given in writing, subject to the stipulated bidding conditions. Based on that, The Board has the right to consider that upon requirement.

33.2 Tickets delivery date shall be 30 dates from the date of award in accordance with ITB 33 in the BDS

34. Evaluation of Bids

34.1 The Purchaser shall evaluate each bid that has been determined, up to this stage of the evaluation, to be substantially responsive.

34.2 To evaluate a Bid, the Purchaser shall only use all the factors, methodologies and criteria defined in this ITB Clause 34.

34.3 To evaluate a Bid, the Purchaser shall consider the following:

- (a) the Bid Price as quoted in accordance with clause 14;
- (b) price adjustment for correction of arithmetic errors in accordance with ITB Sub-Clause 30.3;
- (c) Price adjustment due to discounts offered accordance with ITB Sub-Clause 14.2; and 14.3
- (d) adjustments due to the application of the evaluation criteria specified in the BDS from amongst those set out in Section III, Evaluation and Qualification Criteria;

(e) adjustments due to the application of a domestic preference, in accordance with ITB Clause 34 if applicable.

34.4 The Purchaser's evaluation of a bid may require the consideration of other factors, in addition to the factors stated in ITB Sub-Clause 35; if specified in BDS. These factors may be related to the characteristics, performance, and terms and conditions of purchase of the Goods and Related Services. The effect of the factors selected, if any, shall be expressed in monetary terms to facilitate comparison of bids.

35 Comparison of Bids

35.1 The Purchaser shall compare all substantially responsive bids To determine the lowest-evaluated bid, in accordance with ITB Clause 35.

36 Post-Qualification of the Bidder

36.1 The Purchaser shall determine to its satisfaction whether The Bidder that is selected as having submitted the lowest evaluated and substantially responsive bid is qualified to perform the Contract satisfactorily.

36.2 The determination shall be based upon an examination of the documentary evidence of the Bidder's qualifications submitted by the Bidder, pursuant to ITB Clause 18.

36.3 An affirmative determination shall be a prerequisite for award of the Contract to the Bidder. A negative determination shall result in disqualification of the bid, in which event the Purchaser shall proceed to the next lowest evaluated bid to make a similar determination of that Bidder's capabilities to perform satisfactorily.

37 Purchaser's Right to Accept any Bid, and to reject any or all Bids

37.1 The Purchaser reserves the right to accept or reject any bid, and to annual the bidding process and reject all bids at any time prior to contract award, without thereby incurring any liability to Bidders.

Award of Contract

38 Award Criteria

38.1 The Purchaser shall award the Contract to the Bidder whose offer has been determined to be the lowest evaluated bid and is substantially responsive to the Bidding Documents,

provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.

39 Purchaser's Right to Vary Quantities at the Time of Award

39.1 At the time the Contract is awarded, the Purchaser reserves the right to increase or the decrease the quantity of Goods and Related Services originally specified in Schedule of Requirements, provided this does not exceed twenty five percent (25%) or one unit whichever is higher and without any change in the unit prices or other terms and conditions of the bid and the Bidding Documents.

40 Notification of Award

40.1 Prior to the expiration of the period of bid validity, the Purchaser shall notify the successful Bidder, in writing, that its Bid has been accepted.

40.2 Until a formal Contract is prepared and executed, the notification of award shall constitute a binding Contract.

40.3 Upon the successful Bidder's furnishing of the signed Contract Form and performance security pursuant to ITB Clause 42, the Purchaser will promptly notify each unsuccessful Bidder and will discharge its bid security, pursuant to ITB Clause 20.3.

41. Signing of the contract

41.1 Within Twenty one (21) days after notifications, the purchaser shall complete the agreement and inform the successful Bidder to sign it.

41.2 Within Twenty one (21) days of receipt of such information, the successful Bidder shall sign the Agreement.

42. Performance Security

42.1 Within fourteen days (14) of the receipt of notification of award from the purchaser, the successful Bidder, if required, shall furnish the Performance Security in accordance with the condition of contract, using for that purpose the Performance Security Form included in contract forms. The employer shall promptly notify the name of the winning Bidder to each unsuccessful bidder and discharge the bid securities of the unsuccessful bidders pursuant to ITB Sub – Clause 20.3.

42.2 Failure to the successful Bidder to submit the above mentioned Performance Security or sign the Contract shall constitute sufficient grounds for the annulment of the award and forfeiture of the Bid Security or execution of the Bid – Securing Declaration. In that event the Purchaser may award the contract to the next lowest evaluated Bidder, whose offer is substantially responsive and is determined by the purchaser to be qualified to perform the contract satisfactorily.

- (a) The supplier shall not, without the prior written consent of the Development Lotteries Board, disclose the contract, and/or any provision thereof, and/or sample and/or information furnished by and/or on behalf of the Development Lotteries Board in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only in so far, as may be necessary for purpose of such performance.
- (b) The supplier shall not, without the prior written consent of the Development Lotteries Board, made use of any documents, or information except for purpose of performing the contract.

3. Draw Software Development and provide numbers in soft form for electronic lotteries

3.1 Provide tickets file for e – lotteries in soft form

The supplier should be ready to provide a requested quantity from the total consignment (Ticket File) in soft form for electronic lottery sales and distribution platforms (soft tickets) as per request of Development Lotteries Board within two days at no any extra cost. Supplier should develop an application to manage printed tickets and soft tickets for the aforementioned purpose and application related security should be considered before start the development. Software demonstration should be done for Both AGM-IT and Internal Auditor in DLB before start the operation.

Required File Formats (Name and Content) and File sharing mechanism will be shared by the IT Division of the Development Lotteries Board. Supplier should share the password protected pdf file (soft form) with eTickets Details (serial number range, combinations which are allocated for e-Lotteries/SMS lotteries) to DGM-Finance, AGM- IT and Internal Auditor of the Development Lotteries Board for each draw.

- 3.1.1. The said Supplier should appoint a technical resource or team to support for the entire process of e lottery.
- 3.1.2. Supplier should submit an indemnity Insurance for both printed tickets and soft tickets (e - Lotteries/SMS Lotteries) to cover the over redemption, under redemption and duplications.
- 3.1.3. The said supplier should take the responsibility for duplication or any erroneous combinations in the ticket file (for each brand) until hand over them to Development Lotteries Board.
- 3.1.4. The said supplier should be able to provide ticket files for internal tools which are used for Number combination auditing and analyzing purpose in Development Lotteries Board. Required Ticket File formats will be provided by the IT Division of the Development Lotteries Board.
- 3.1.5. Total consignment for the particular brand should be handed over to the DGM- Finance and AGM-IT in a password protected CD once its generated.
 - Further below, separate ticket files need to be uploaded for the given location:
 1. Total Consignment File
 2. Daily Draw Allocation
 The required format and upload path will be provided to the selected bidder.
- 3.1.6. The said supplier should hand over the Printer Certificate to Audit Superintendent in Government Audit Division by 2.00 p.m. on draw date with serial number range which used to print and other required information of each brand.
- 3.1.7. Total consignment (Password protected ticket file in a CD) of each draw should be handed over to Audit Superintendent in Government Audit Division daily basis.

3.2 Draw Software Development

Draw software development is the one of the major tasks of the printer. Selected supplier should develop, modify and test the draw software according to the requirements given by the IT division. Additionally, Selected bidder should be ready to do time to time software modifications, testing without any extra cost.

Please find the import and export files of the draw software.

- Imports : Sales file given by the Lottery Management system, Agent File and Ticket File
- Inputs : Winning numbers taken from the draw machines. Inputs should be validated
- Example: Minimum Value, Maximum Value, etc.
- Outputs : Required reports, Encrypted File bundle including winner file for printed tickets, Winner file for soft tickets, Json file, XML file and other image files. Encryption standards will be provided after the tender process.

- 3.2.1 Draw Software should support for ticket wise processing and book wise processing since both printed tickets and eTickets sales are included in the same Sales File. Printed Tickets Sales are processed in book wise and soft tickets sales are processed in ticket wise.
- 3.2.2 Supplier should generate Separate Winner Files for printed tickets and eTickets. Required format will be provided by the IT Division of the Development Lotteries Board.
- 3.2.3 Supplier should provide Reports by including printed tickets and eTickets winnings as Full Report and separate reports for printed tickets & eTickets. Format will be provided by IT Division of the Development Lotteries Board.
- 3.2.4 Supplier should maintain documents for software development and provide release document for each and every release. Additionally, Supplier should provide test cases and status of the testing when DLB IT requested.
- 3.2.5 Supplier should provide facility to review the source code for the draw software with the presence of an IT representative of the supplier when request by AGM-IT or an Internal auditor. IT representative should explain the logic used for the draw software in front of the IT officials of the DLB.
- 3.2.6 When Development Lotteries Board instructed to do any changes, enhancement or modifications relevant to the draw software, supplier is liable to do the required system developments and said developments should be thoroughly tested at no extra cost. Further User Acceptance Testing process should be completed with the IT division of the Development Lotteries Board and the written consent of Development Lotteries Board should be mandatory for any system modifications to deploy on the production environment.
- 3.2.7 Selected bidder should be liable to purchase required software libraries, frameworks, Database licenses or any other dependencies to run Draw Software in the production environment for each and every brand separately. Supplier is liable for all type of failures of the draw software because of a licensing issues, poor implementation issues, logic related issue or third-party libraries issues. Operating system updates, environment updates and other required information maintenance should be done with DLB IT resources and both parties should be participated for such events physically. Remote updates/operations are not allowed for draw software for any reason.
- 3.2.8 Draw Software application should be supported to merge draw sales if the draws cannot be conducted as scheduled due to unavoidable circumstances. As a result, the application process should be simplified in order to perform a single draw for the aforementioned drawings.

Merge sales files, as previously stated, contain sales from several dates (ex: 02 or more). As a result, a single draw will be performed, and a single report will be generated with an XML file for the combined sales file. For the specified draws, separate result packages with winner files and prize distribution images should be prepared. Should be done time to time modification

- 3.2.9 Supplier should be liable to nominate a technical support person to inform issues related to the draw software. Aforesaid support person should be liable to support at any time in case of any issue failures occurred (24*7).
- 3.2.10 Further the Technical Support person should be participated to the particular draw process daily and should be stayed at the studio until complete the whole draw process without any extra cost
- 3.2.11 The QR code must be printed on the ticket as per the instructions provided by DLB and should facilitate winner verification through the DLB website.

3.3 Number Generation Software Development

Number Generation Software is a main application which involve with lottery printing. Supplier should be liable for the accuracy of the generated numbers and set of numbers must not be repeated in a particular consignment. Supplier should improve the quality of the number generation tool (Especially the number generation algorithm) in order to keep the normality of the prize distribution which should be accepted by the IT division of the Development Lotteries Board. Unless, Supplier should develop the number generation algorithm for the given set of rules (Selected bidder will receive a set of rules) which helps to improve the prize distribution. Expected prize structure of the game should be proportionally distributed with ticket sale or for a given set. Number generation software is required for each and every brand in separately.

The successful bidder will be required to implement a ticket file validation system that thoroughly checks and confirms the content of each ticket file before initiating the printing process. This system should be equipped to identify any duplication or erroneous combinations within the ticket file, ensuring that only accurate and unique ticket information is printed.

The selected bidder must provide reports and graphs for each consignment, confirming that it meets the DLB requirements and constraints as follows, contains no duplicates or errors, and is properly and equally distributed prizes. The report should include details such as:

- The number of occurrences of each English letter
- The number of occurrences of each symbol/sign
- The number of occurrences of each digit
- Comparison of standard & actual prizes of relevant matches
- Guaranteed prize per book, per 1,000 tickets & per 10,000 books
- Any other relevant details to check this prize distribution

Additionally, the printer must include a comparison in the report between the prize distribution structure of the daily draw allocation and the total consignment to evaluate prize distribution.

In the event that the validation system identifies any issues within the ticket file, the supplier should promptly and efficiently inform to the IT division of the Development Lotteries Board. This communication should include the necessary steps taken to rectify any duplications or erroneous combinations, by ensuring the integrity of the information is maintained.

Once the supplier accepts the validated ticket file, supplier should liable for any combinations within the ticket file, specifically tailored to each brand, to maintain the consistency and quality of process.

- 3.3.1 Supplier should handover the sample ticket files to Development Lotteries Board and its required to get an approval from AGM-IT or his authorized officer of Development Lotteries Board before start the printing process for the generated consignment.

- 3.3.2 Supplier should be prepared to do “N” number of modifications for Number Generation Software in order to improve the quality of the numbers when requested by DLB IT division or Internal audit division.

In a scenario where DLB will provide lottery combinations in the future, the selected bidder is responsible for printing and producing the given combinations accordingly. However in such a scenario a selected service provider is liable to provide the draw software to calculate winners.

The successful bidder will be required to implement a ticket file validation system that thoroughly checks and confirms the content of each ticket file before initiating the printing process. This system should be equipped to identify any duplication or erroneous combinations within the ticket file, ensuring that only accurate and unique ticket information is printed.

3.4 Draw Software Development for Special Draws

- 3.4.1 Supplier should support for the all requirements given under the 3.1 Provide tickets file for e – lotteries in soft form.
- 3.4.2 Supplier should be able to do any modification in the Draw software/Special draw software or any other software tool which is included in the scope as per the instructions given by DLB. Selected supplier is liable to do the required modifications as and when necessary at no extra cost.
- 3.4.3 Prior to the installation of the Special Draw Software to the Draw laptops, the Supplier should demonstrate the business logic and the source code for the special Draw to the AGM-IT or his authorized officers and obtain the approval. All the transactions/process should follow in accordance with the Special Draw Policies, standards and procedures.
- 3.4.4 Upon the completion of Software system for Lottery Printing, Number Generation Algorithm and Results Processing/Calculation, a software Audit report should be obtained from a reputed software audit firm of chartered accountants of Sri Lanka. Audit report to be submitted within 60 days of the contract commencement to DLB. Audit guideline is enclosed as Annexure 02.
- 3.4.5 The software developed by the supplier must be audited by a certified software auditing firm and the audit report submitted to DLB. Any identified bugs or issues must be rectified by the supplier.
Upon signing the agreement, if the supplier fails to submit the software audit report within 60 days, as stipulated in Clause No 3.4.4, DLB reserves the right to withhold 10% of the monthly payment. The final payment will be released based on the findings of the software audit report. If the printer fails to submit the software audit report after the initial 60-day period, DLB has the right to forfeit the withheld amount.
If the printer fails to submit the software audit report within 105 days of signing the agreement, DLB reserves the right to terminate the agreement.
- 3.4.6 Authorized auditor of DLB has right to audit the entire printing system/software system/plants and machinery when necessary, by giving short notice.

3.5 Software Rights

The supplier shall retain full rights to the software developed related to this contract. Any legal issues arising from the software shall be the sole responsibility of the supplier and DLB shall not be held liable. Any claims for damages made by third parties shall be borne entirely by the supplier.

3.6 Support & Maintenance

- 3.6.1 The Supplier shall provide technical support and maintenance for a period of 12 months after development.
- 3.6.2 Emergency fixes for security vulnerabilities must be addressed within 01 hour of reporting.

3.7 Termination & Exit Strategy

- 3.7.1 Upon termination, the Supplier shall provide the all documentation and necessary technical details handover to the DLB.
- 3.7.2 The supplier shall delete all copies of the software and related data upon termination, except for archival copies required for compliance.

4. Supplier is liable to provide below information of the Hardware infrastructure.

- 4.1 Supplier should keep a firewall (with appliance or without appliance) in order to protect information assets in the organization.
- 4.2 Supplier should implement a proper backup process and backup data should be kept in a secured manner. Provide information for the backup process. Further a disaster recovery system must be in place to handle emergency situation.
- 4.3 Supplier should keep all the backups in their custody for at 12 years as per the RTI act. Provide them for the legal requirement/forensic investigations when DLB requested.
- 4.4 Supplier should keep backup servers in order to improve the high availability of the systems. Documentary evidence should be provided.
- 4.5 Supplier should take all necessary steps to protect all type of information assets and introduce security controls to protect from cyber/Insider threats. Provide documentary evidence when requested by IT Division or Internal Auditor of the DLB.
- 4.6 Supplier should provide internal policies and procedures that they have enforced in the organization when requested by DLB IT Division or Internal Auditor of the DLB.

5. Site Inspection

- 5.1 On approval of the Standard High Level Procurement Committee(SHLPC) the Technical Evaluation Committee and/or their authorized representatives shall have free access to inspect the site where the Draw Lottery Tickets are proposed to be printed. This inspection will be done prior to accepting the offers at all reasonable times without giving any prior notice.

5.2. Pricing :-

Price Quoted of : - Prospective bidders should quote their prices for designing, developing, printing & supplying of Draw Lottery tickets as per the specifications and other services required by the DLB. Technical specifications and other services required are specified under separate schedules in Page numbers No.70-79. Development Lotteries Board reserves its sole right to change the artwork 02 times per annum without any extra cost (in addition to first artwork). If any additional art work change by the Development Lotteries Board, plate making charge will be paid accordingly. Further cost of the plate making should be quoted in the price Schedule (Pag No.62) by the bidder. The prize structure in compliance with the requirements that may arise from time to time.

Optional prices should be submitted as per the clause no 8.3 of the technical specification using the price schedule on pages 61 for the supply of printed on 100gsm offset white printing paper (Bank Paper) with security features including, to verify the authenticity of the lottery, the ticket price figure Rs. 40/- or Rs. 20/- should be printed using heat-reactive ink, which becomes visible when rubbed with a finger. This offer is not considered for financial evaluation.

5.3. Payments:-

Terms of Payment: - Full payment against the presentation of the original invoice will be made within 30 days of the respective draw date (or within 30 days from the submission of the date of invoice) of the tickets, subject to the quality and quantity certificate issued by the officer/officers appointed by the Development Lotteries Board. DLB shall have the right to re print the total quantity on free of charge or reduce the cost of the damage occurred due to poor quality and printing mistakes of tickets from an invoice as per the attached penalty list (Annex 1)

6. Contract not to be Sublet:-

The supplier should not assign or sublet his obligations of any part of the process of production of Draw Lottery Tickets required to be designed, developed, printed, supplied to the Development Lotteries Board.

7. Delivery within Agreed Period:-

- a. All deliveries of Draw Lottery tickets should be made in unopened packs and in the manner required by the Development Lotteries Board within the agreed period of time and at the expense of the supplier. Security should be provided from the point of dispatching and until officially handed over

to the Development Lotteries Board. Delivery notes should be certified by the supplier and the officer/s nominated by the Development Lotteries Board.

- b. Should the supplier anticipate at any time during the period of the execution of the contract that he will not be able to comply with the time schedule for delivery Supplier shall inform such fact promptly in writing to the Chairman, Development Lotteries Board explaining the cause for the delay and the period involved. In case of any delay, the Development Lotteries Board shall have the option either to grant an extension or to terminate the contract and collect the Performance Bond without prejudice to any other and further claims that may be lodged in this regard.

Whatever the additional cost on account of prizes arising from such willful commission, omission or error, fault, addition or deficiency of any description in the process of production shall be met by the supplier. Selected supplier must be submitted professional indemnity insurance policy as per the following insurance values given and submission to the DLB prior to the signing of the agreement insurance premium should be borne by the supplier. Development Lotteries Board indemnifying the Development Lotteries Board against any additional cost on account of prizes arising from such willful commission, omission, or error, fault, addition or deficiency of any description in the process of production in the Printed form or soft form of lottery as well. For greater certainty and clarity, it is declared that the coverage provided by the said insurance policy limits. Clearly worded certificate of insurance to be submitted with a reinsurance documents issued by a recognized reinsurance company prior to the signing of the contract by the selected bidder. DLB has sole right to increase or decrease the insurance value with the requirement that may arise from time to time. Supplier is liable to enhance the value of the insurance policy at his own cost on the request made by the DLB.

As such occasion, selected supplier liable for re submission of insurance policy on their (suppliers) own cost.

9.Governing Law :-

The bidders and any contract resulting there from shall be governed by and construed according to the Laws of Sri Lanka currently in force and that may be enacted from time to time by the Government of Sri Lanka in future.

10.Conditions of the Bid: -

Conditions of Contract

1. Definitions
- 1.1 The following words and expressions shall have the meanings Hereby assigned to them:
- (a) “Contract” means the Contract Agreement entered into between the Purchaser and the Supplier, together with the Contract Documents referred to therein, including all attachments, appendices, and all documents incorporated by reference therein.
 - (b) “Contract Documents” means the documents listed in the Contract Agreement, including any amendments thereto.
 - (c) “Contract Price” means the price payable to the Supplier as specified in the Contract Agreement, subject to such additions and adjustments thereto or deductions there from, as may be made pursuant to the Contract.
 - (d) “Day” means calendar day.
 - (e) “Completion” means the fulfillment of the supply of Goods to the destination specified and completion of the Related Services by the Supplier in accordance with the terms and conditions set forth in the Contract.
 - (f) “CC” means the Conditions of Contract.
 - (g) “Goods” means all of the commodities, raw material, machinery and equipment, and/or other materials that the Supplier is required to supply to the Purchaser under the Contract.
 - (h) “Purchaser” means the entity purchasing the Goods and Related Services, as specified in the Contract Data.
 - (i) “Related Services” means the services incidental to the supply of the goods, such as insurance, installation training and initial maintenance and other such obligations of the Supplier under the Contract.
 - (j) “Subcontractor” means any natural person, private or government entity, or a combination of the above, to whom any part of the Goods to be supplied or execution of any part of the Related Services is subcontracted by the Supplier.
 - (k) “Supplier” means the natural person, private or government entity, or a combination of the above, whose bid to perform the Contract has been

accepted by the Purchaser and is named as such in the Contract Agreement.

(l) “The Project Site,” where applicable, means the place named in the Contract Data.

(m) “IT” means Information Technology

2. Contract documents 2.1 Subject to the order of precedence set forth in the Contract Agreement, all documents forming the Contract (and all parts thereof) are intended to be correlative, complementary, and mutually explanatory. The Contract Agreement shall be read as a whole.

3. Fraud and Corruption 3.1 The Government of Sri Lanka requires the Purchaser as well as bidder, suppliers, contractors, and consultants to observe the highest standard of ethics during the procurement and execution of such contracts. In pursuit of this policy:

(i) “corrupt practice” means offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence the action of a public official in the procurement process or in contract execution;

(ii) “fraudulent practice” means a misrepresentation or omission of facts in order to influence a procurement process or the execution of a contract.

(iii) “collusive practice” means a scheme or arrangement between two or more bidders, with or without the knowledge of the Purchaser to establish bid prices at artificial, noncompetitive levels; and

(iv) “coercive practice” means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the procurement process or affect the execution of contract.

4. Interpretation 4.1 If the context so requires it, singular means plural and vice versa.

1. Entire Agreement

The Contract constitutes the entire agreement between the Purchaser and the Supplier and supersedes all communications, negotiations and agreements (whether written or oral) of the parties with respect thereto made prior to the date of Contract.

i. Amendment

No amendment or other variation of the Contract shall be valid unless it is in writing, is dated, expressly refers to the Contract, and is signed by a duly authorized representative of each party thereto.

General Conditions of Contract

- 4.2.2 Severability
If any provision or condition of the Contract is prohibited or rendered invalid or unenforceable, such prohibition, invalidity or unenforceability shall not affect the validity or enforceability of any other provisions and conditions of the Contract.
5. Language
- 5.1 The Contract as well as all correspondence and documents relating to the Contract exchanged by the Supplier and the Purchaser, shall be written in English language. Supporting documents and printed literature that are part of the Contract may be in another language provided they are accompanied by an accurate translation of the relevant passages in the language specified, in which case, for purposes of interpretation of the Contract, this translation shall govern.
- 5.2 The Supplier shall bear all costs of translation to the governing language and all risks of eth accuracy of such translation, for documents provided by the Supplier.
6. Joint Venture, Consortium or Association
- 6.1 If the Supplier is a joint venture, consortium or association, all of the parties Shall be jointly and severally liable to the Purchaser for the fulfillment of the provisions of the Contract and shall designate one Parties to act as a leader with authority to bind the joint venture, consortium, or association. The composition or the constitution of the joint venture, consortium, or association shall not be altered without the prior consent of the Purchaser.
7. Eligibility
- 7.1 All goods supplied under this contract shall be complied with Applicable standards stipulated by the Sri Lanka Standards institute. In the absence of such standards, the Goods supplied shall be complied to other internationally accepted standards, such as British Standards.
8. Notices writing
- 8.1 Any notice given by one party to the pursuant to the Contract shall be in to the address specified in the Contract Data. The term “in writing” means communicated in written form with proof or receipt.
- 8.2 A notice shall be effective when delivered or on the notice’s effective date, whichever is later.
9. Governing Law laws
- 9.1 The Contract shall be governed by and interpreted in accordance with the of the Democratic Socialist Republic of Sri Lanka.
10. Settlement of Disputes
- 10.1 The purchaser and the Supplier shall make every effort to resolve amicably By direct informal negotiation any disagreement or dispute arising between them under or in connection with the Contract.

General Conditions of Contract

10.2 If, after twenty-eight (28) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the Purchaser or the Supplier may give notice to the other party of its intention to commence arbitration, as hereinafter provided, as to the matter in dispute, and no arbitration in respect of this matter may be commenced unless such notice is given. Any dispute or difference in respect of which a notice of intention to commence arbitration has been given in accordance with this Clause shall be finally settled by arbitration. Arbitration may be commenced prior to or after delivery of the Goods under the Contract. Arbitration proceedings shall be conducted in accordance with the Arbitration Act No: 11 of 1995.

10.3 Notwithstanding any reference to arbitration herein,

- (a) the parties shall continue to perform their respective obligations under the Contract unless they otherwise agree and

Security

- 17.1 If required as specified in the Contract Data, the Supplier shall, within Fourteen days (14) of the notification of contract award, provide a performance security of Ten percent (10%) of the Contract Price for the performance of the Contract.
- 17.2 The proceeds of the Performance security shall be payable to the Purchaser as compensation for any loss resulting from the Supplier's failure to complete its obligations under the Contract.
- 17.3 As specified in the Contract Data, the Performance Security, if required, shall be in Sri Lanka Rupees and shall be in the format stipulated by the Purchaser in the Contract Data, or in another format acceptable to the Purchaser.
- 17.4 The Performance Security shall be discharged by the Purchaser and returned to the Supplier not later than thirty (30) days following the date of Completion of the Supplier's performance obligations under the Contract, including any warranty obligations.

18. Copyright data

- 18.1 The copyright in all drawing, documents, and other materials Containing and information furnished to the Purchaser by the Supplier herein shall remain vested in the Supplier, or, if they are furnished to the Purchaser directly or through the Supplier by any third party, including suppliers of materials, the copy right in such materials shall remain vested in such third party.

19. Confidential Information

- 19.1 The Purchaser and the Supplier shall keep confidential and shall not, without the written consent of the other party hereto, divulge to any third party any documents, data or other information furnished directly or indirectly by the other party hereto in connection with the Contract, whether such information has been furnished prior to, during or following completion or termination of the Contract. Notwithstanding the above, the Supplier may furnish to its Sub-contractor such document, data and other information it receives from the Purchaser to the extent required for the Subcontractor to perform its work under the Contract, in which event the Supplier shall obtain from such Subcontractor an undertaking of confidentiality similar to that imposed on the Supplier under CC Clause 19.
- 19.2 The Purchaser shall not use such documents, data, and other information received from the Supplier for any purposes unrelated to the contract. Similarly, the Supplier shall not use such documents, data, and other information received from the Purchaser for any purpose other than the performance of the Contract.
- 19.3 The above provisions of CC Clause 19 shall not in any way modify any undertaking of confidentiality given by either of the parties hereto prior to the date of the Contract in respect of the Supply or any part thereof.
- 19.4 The provisions of CC Clauses 19 shall survive completion or termination, for whatever reason, of the Contract.

20. Subcontracting
- 20.1 The Supplier shall notify the Purchaser in writing of all subcontracts awarded under the Contract if not already specified in the bid. Such notification, in the original bid or later shall not relieve the Supplier from any of its obligations, duties, responsibilities, or liability under the Contract.
- 20.2 Subcontracts shall comply with the provisions of CC Clauses 3 and 7.
21. Specification and Standards
- 21.1 Technical Specifications and Drawings
- (a) The Goods and Related Services supplied under this Contract shall conform to the technical specifications and standards mentioned in Section V, Schedule of Requirements and when no applicable standard is mentioned, the standard shall be equivalent or superior to the official standards whose application is appropriate to the Goods country of origin.
- (b) The supplier shall be entitled to disclaim responsibility for any design, data, drawing, specification or other document, or any modification thereof provided or designed by or on behalf of the Purchaser, by giving a notice of such disclaimer to the Purchaser.
- (c) Wherever references are made in the Contract to codes and standards, in accordance with which it shall be executed, the edition or the revised version of such codes and standards shall be those specified in the schedule of Requirements. During Contract execution, any changes in any such codes and standards shall be applied only after approval by the Purchaser and shall be treated in accordance with CC Clause 32.
22. Packing and Documents
- 22.1 The Supplier shall pack the Goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the Contract.
23. Insurance the
- 23.1 Unless otherwise specified in the Contract Data, the Goods supplied under Contract shall be fully insured against losses or damages incidental to manufacture or acquisition, transportation, storage, and delivery.
24. Transportation
- 24.1 Unless otherwise specified in the Contract Data, responsibility for arranging transportation of the Goods shall be a responsibility of the supplier.
25. Inspection and Tests
- 25.1 The Supplier shall at its own expense and at no cost to the Purchaser carry out all such tests and/or inspections of the Goods and Related Services as specified in the Contract Data.
- 25.2 The inspections and tests may be conducted on the premises of the Supplier or its Subcontractor, at point of delivery, and/or at the Goods' final destination, or in another place as specified in the Contract data. Subject to CC Sub-Clauses 25.3, if conducted on the premises of the Supplier or its Subcontractor,

all reasonable facilities and assistance, including access to drawings and production data, shall be furnished to the inspectors at no charge to the Purchaser.

- 25.3 The Purchaser or its designated representative shall be entitled to attend the tests and/or inspections referred to in CC Sub-Clause 25.2, provided that the Purchaser bear all of its own costs and expenses incurred in connection with such attendance including, but not limited to, all traveling and board and lodging expenses.
- 25.4 Whenever the Supplier is ready to carry out any such test and inspection, it shall give a reasonable advance notice, including the place and time, to the Purchaser. The Supplier shall obtain from any relevant third party or manufacture any necessary permission or consent to enable the Purchaser or its designated representative to attend the test and/or inspection.
- 25.5 The Purchaser may require the supplier to carry out any test and/or inspection not required by the Contract but deemed necessary to verify that the characteristics and performance of the Goods comply with the technical specifications codes and standards under the Contract, provided that the Supplier's reasonable costs and expenses incurred in the carrying out of such test and/or inspection shall be added to the Contract Price. Further, if such test and/or inspection impedes the progress of manufacturing and/or the Supplier's performance of its other obligations under the Contract, due allowance will be made in respect of the delivery dates and completion dates and the other obligations so affected.
- 25.6 The Supplier shall provide the Purchaser with a report of the results of any such test and/or inspection.
- 25.7 The Purchaser may reject any Goods or any part thereof that fail to pass any test and/or inspection or do not conform to the specifications. The supplier shall either rectify or replace such rejected goods or parts thereof or make alterations necessary to meet the specifications at no cost to the Purchaser, and shall repeat the test and/or inspection, at no cost to the Purchaser, upon giving a notice pursuant to CC Sub-Clause 25.4
- 25.8 The Supplier agrees that neither the execution of a test and/or inspection of the Goods or any part thereof, nor the attendance by the Purchaser or its representative, nor the issue of any report pursuant to CC Sub-Clause 25.6, shall release the Supplier from any warranties or other obligations under the Contract.

26. Liquidated Damages 26.1 Except as provided under CC Clause 31, if the Supplier fails to deliver any or all of the Goods by the Date(s) of delivery or perform the Related services within the period specified in the Contract, the Purchaser may without prejudice to all its other remedies under the Contract, deduct from the Contract price, as liquidated damages, a sum equivalent o the percentage specified in the Contract Data of the delivered price of the delayed goods or unperformed services for each week or part thereof delay until actual delivery

or performance, up to a maximum deduction of the percentage specified in those Contract data. Once the maximum is reached, the Purchaser may terminate the Contract pursuant to CC Clause 34.

27. Warranty
- 27.1 The Supplier warrants that all the Goods are new, unused, and of the most recent or current models, and that they incorporate all recent improvements in design and materials, unless provided otherwise in the Contract.
- 27.2 Subject to CC Sub-Clause 21.1 (b), the Supplier further warrants that the Goods shall be free from defects arising from any act or omission of the supplier or arising from design, materials, and workmanship, under normal use in the conditions prevailing in the country of final destination.
- 27.3 Unless otherwise specified in the Contract data, the warranty shall remain valid for twelve (12) months after the Goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the Contract Data.
- 27.4 The Purchaser shall give notice to the Supplier stating the nature of any such defects together with all available evidence thereof, promptly following the discover thereof. The Purchaser shall afford all reasonable opportunity for the Supplier to inspect such defects.
- 27.5 Upon receipt of such notice, the Supplier shall, within the period specified in the Contract Data, expeditiously repair or replace the defective goods or parts thereof, at no cost to the Purchaser.
- 27.6 If having been notified, the Supplier fails to remedy the defect within the period specified in the Contract Data, the Purchaser may proceed to take with a reasonable period such remedial action as may be necessary at the Supplier's risk and expenses and without prejudice to any other rights which the Purchaser may have against the Supplier under the Contract.

28. Patent Indemnity 28.1 The Supplier shall, subject to the Purchaser's compliance with CC Sub-Clause 28.2 , indemnify and hold harmless the Purchaser and its employees and officers from and against any and all suits, actions or administrative proceedings, claims, demands, losses, damages, costs, and expenses of any nature, including attorney's fees and expense, which the Purchaser may suffer as a result of any infringement or alleged infringement of any patent, utility model, registered design, trademark, copyright, or other intellectual property right registered or otherwise existing at the date of the Contract by reason of:

- (a) The installation of the Goods by the Supplier or the use of the Goods in the country where the site is located; and
- (b) The sale in any country of the products produced by the Goods.

Such indemnity shall not cover any use of the Goods or any part thereof other than for the purpose indicated by or to be reasonably inferred from the

contract, neither any infringement resulting from the use of the Goods or any part thereof, or any products produced thereby in association or combination with any other equipment, plant, or materials not supplied by the Supplier pursuant to the Contract.

- 28.2 If any proceedings are brought or any claim is made against the Purchaser arising out of the matters referred to in CC Sub-clause 28.1 the Purchaser shall promptly give the Supplier a notice thereof, and the Supplier may at its own expense and in the Purchaser's name conduct such proceedings or claim and any negotiations for the settlement of any such proceedings or claim.
- 28.3 If the Supplier fails to notify the Purchaser with twenty-eight (28) days after receipt of such notice that it intends to conduct any such proceedings or claim, then the purchaser shall be free to conduct the same on its own behalf.
- 28.4 The Purchaser shall, at the supplier's request, afford all available assistance to the Supplier in conducting such proceedings or claim, and shall be reimbursed by the supplier for all reasonable expenses incurred in so doing.
- 28.5 The purchaser shall indemnify and hold harmless the Supplier and its employees, officers, and Subcontractors from and against any and all suits, actions or administrative proceedings, claims demands, losses, damages, costs, and expenses of any nature, including attorney's fees and expenses, which the Supplier may suffer as a result of any infringement or alleged infringement of any patent, utility model, registered design, trademark, copyright, or other intellectual property right registered or otherwise existing at the date of the Contract arising out of or in connection with any design, data, drawing, specification, or other documents or materials provided or designed by or on behalf of the Purchaser.

29. Limitation of Liability

- 29.1 Except in cases of criminal negligence or willful misconduct,
- (a) The Supplier shall not be liable to the Purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the Supplier to pay liquidated damages to the Purchaser and
- (b) The aggregate liability of the Supplier to the Purchaser, whether under the Contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment, or to any obligation of the supplier to indemnify the purchaser with respect to patent infringement.

30. Change in Laws And Regulations

- 30.1 Unless otherwise specified in the Contract, if after the date of 28 days prior to date of Bid submission, any law, regulation, ordinance, order or bylaw having the force of law is enacted, promulgated, abrogated, or changed in Sri Lanka that subsequently affects the Delivery Date and/or the Contract Price, then such delivery date and/or contract price shall be correspondingly increased or

decreased, to the extent that the Supplier has thereby been affected in the performance of any of its obligations under the Contract. Notwithstanding the foregoing, such additional or reduced cost shall not be separately paid or credited if the same has already been accounted for in the price adjustment provisions where applicable, in accordance with CC Clause e 14.

31. Force Majeure
- 31.1 The Supplier shall not be liable for forfeiture of its Performance Security, liquidated damages, or termination for default if and to the extent that its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.
- 31.2 For purposes of this Clause, “Force Majeure” means an event or situation beyond the control of the supplier that is not foreseeable, is unavoidable, and its origin is not due to negligence or lack of care on the part of the Supplier. Such events may include, but not be limited to, acts of the Purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions, and freight embargoes.
- 31.3 If a Force Majeure situation arises, the Supplier shall promptly notify the Purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the Purchaser in writing, the supplier shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all Reasonable alternative means for performance not prevented by the Force Majeure event.
32. Change orders
And Contract
Amendments
- 32.1 The Purchaser may at any time order the supplier through notice in accordance CC Clause 8, to make changes within the general scope of the Contract in any one or more of the following:
- (a) Drawings, designs, or specifications, where Goods to be furnished under the Contract are to be specifically manufactured for the Purchaser;
 - (b) The method of packing;
 - (c) The place of delivery; and
 - (d) The Related services to be provided by the Supplier.
- 32.2 If any such change causes an increase or decrease in the cost of, or the time required for, the Supplier’s performance of any provisions under the Contract, an equitable adjustment shall be made in the Contract Price or in the Delivery / Completion Schedule, or both, and the Contract shall accordingly be amended. Any claims by the Supplier for adjustment under this Clause must be asserted within twenty-eight (28) days from the date of the Supplier’s receipt of the Purchaser’s change order.
- 32.3 Prices to be charged by the supplier for any related services that might be needed but which were not included in the Contract shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the Supplier for similar services.

General Conditions of Contract

- 32.4 Subject to the above, no variation in or modification of the terms of the Contract shall be made except by written amendment signed by the parties.
33. Extensions of time
- 33.1 If at any time during performance of the Contract, the supplier or its Sub-contractors should encounter conditions impeding timely delivery of the Goods or completion of related services pursuant to CC Clause 12, the Supplier shall promptly notify the Purchaser in writing of the delay, its likely duration, and its cause. As soon as practicable after receipt of the Supplier's notice, the Purchaser shall evaluate the situation and may at its discretion extend the Supplier's time for performance, in which case the extension shall be ratified by the parties by amendment of the Contract.
- 33.2 Except in case of Force Majeure, as provided under CC Clause 31, a delay by the Supplier in the performance of its Delivery and Completion obligations shall render the Supplier liable to the imposition of liquidated damages pursuant to CC Clause 26, unless an extension of time is agreed upon, pursuant to CC Sub-Clause 33.1.
34. Termination
- 34.1 Termination for Default
- (a) The purchaser, without prejudice to any other remedy for breach of Contract, by written notice of default sent to the Supplier, may terminate the Contract in whole or in part.
- (i) If the Supplier fails to deliver any or all of the Goods within the period specified in the Contract, or within any extension thereof granted by the Purchaser pursuant to CC Clause 33;
- (ii) If the Supplier fails to perform any other obligation under the contract; or
- (iii) If the Supplier in the judgment of the Purchaser has engaged in fraud and corruption, as defined in CC clause 3, in competing for or in executing the Contract.
- (b) In the event the Purchaser terminates the Contract in whole or in part, pursuant to CC Clause 34.1 (a), the Purchaser may procure, upon such terms and in such manner as it deems appropriate, goods or related services similar to those undelivered or not performed, and the Supplier shall be liable to the Purchaser for any additional costs for such similar Goods or related services. However, the Supplier shall continue performance of the Contract to the extent not terminated.
- 34.2 Termination for Insolvency
- (a) The Purchaser may at any time terminate the Contract by giving notice to the Supplier if the Supplier becomes bankrupt or otherwise insolvent. In such event, termination will be without compensation to the Supplier provided that such termination will not prejudice or affect any right of action or remedy that has accrued or will accrue thereafter to the Purchaser

34.3 Termination for Convenience

- (a) The Purchaser, by notice sent to the supplier, may terminate the Contract, in whole or in part, at any time for its convenience. The notice of termination shall specify that termination is for the Purchaser's convenience, the extent to which performance of the Supplier under the Contract is terminated, and the date upon which such termination becomes effective.
- (b) The Goods that are complete and ready for shipment / delivery within twenty-eight (28) days after the Supplier's receipt of notice of termination shall be accepted by the Purchaser at the Contract terms and prices. For the remaining Goods, the Purchaser may elect.
 - (i) To have any portion completed and delivered at the Contract terms and prices; and/or
 - (ii) To cancel the remainder and pay to the Supplier an agreed amount for partially completed Goods and related services and for materials and parts previously procured by the supplier.

35. Assignment

- 35.1 Neither the Purchaser nor the Supplier shall assign, in whole or in part, their obligations under this contract, except with prior written consent of the other party.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Bid referred to.
2. Agreement will be valid for one years from the date of signing.
3. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.
 - a) Bid Form
 - b) General Conditions of Bidder
 - c) Special Conditions
 - d) General Specifications and Technical Specifications
 - e) Price Schedules
 - f) Description of Basic Services required
 - g) All other relevant documents in the Bid document
 - h) Machinery and Technical Details
4. In consideration of the payments to be made by the Purchaser to the supplier as hereinafter mentioned, the supplier hereby covenants with the Purchaser to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Agreement.
5. The Purchaser hereby covenants to pay the supplier in consideration of the provision of the goods and services and the remedying of defects herein, the Contract Price or such other sum as may become payable under the provisions of the Agreement at the times and in the manner prescribed by the Agreement.
6. DLB has right to deduct penalties as per the penalty list attached with the bidding document as liquidated damages for any faults in the draw related software, which pursuance the successful completion of draw including pre and post processing.
7. In case of merging of 2 consignments and the same combination is repeated, the cost of the prizes has to be paid to the Purchaser by the supplier.

8. The monthly requirement of tickets shall be decided by the Development Lotteries Board and communicated 30 days prior to the draw date to the supplier.(Period shall be changed due to the market situation) Supplier is liable to deliver it before 14 days of the respective draw date. 9. Depending on the market requirements, the Development Lotteries Board may request the supplier to supply and deliver additional quantities than the usual order/s. In such an event, the supplier should make arrangements to supply and additional quantity of 20,000 tickets within 04 hours and 250,000 tickets within 12 hours including holidays & weekends.

In case of failure to supply the additional orders on time, the supplier should liable to compensate the loss as per the penalty list attached

10. Following the Commissioning of the supplier system to the satisfaction of the Chairman, of the Development Lotteries Board, the supplier shall place the source codes of all operational software of which the authenticity has been verified jointly by the Development Lotteries Board and the supplier , related documentation and all relevant pass words in the Bank of ceylon Union Place Branch, to be held by the Bank of ceylon in "Escrow" for access by the Development Lotteries Board in the event of bankruptcy or any other instance of the termination of the Agreement. All cost payable to the Bank in this regard will be borne by the Development Lotteries Board.

11. Supplier should keep all the backups in their custody for at 12 years as per the RTI act. Provide them for the legal requirement/forensic investigations when DLB requested.

12.This Agreement constitutes the entire understanding between the parties as to the subject matter thereof and may be amended or modified only by an agreement in writing signed by both parties.

LOTTERY SUPPLIERS & CONTRACTORS' LIABILITY POLICY

Whereas the Insured named in the Schedule has made to the (hereinafter called "the Insurers") a written proposal and has supplied to the Insurers certain information the particulars and statements of which shall form the basis of the Insurance and are to be considered as incorporated herein.

In consideration of the payment of the premium herein, the Insurers agree (subject to the Conditions, Provisions and Exclusions contained herein or endorsed or otherwise expressed hereon which shall be deemed to be conditions precedent to the right of the Insured to recover hereunder) to indemnify the insured up to but not exceeding the limit or limits stated in the schedule for any sum or sums which the insured may become legally liable to pay arising from any claim or claims made against them during the period stated in the Schedule as a direct result of any negligent act, error or omission in the conduct and execution of the Activities defined in the Schedule.

COVERAGES

1. The Insurers hereby agree to indemnify the respective Insured for their liability necessarily assumed under the terms of the respective Rules and Regulations of any such Lottery Game limited however for the purposes of this Section of this Policy to the actual additional cost incurred by the respective Insured in the provision of additional prizes to legitimate winners should the total of all prizes won by legitimate winners exceed 100% of the Available Prize Fund (as defined) in any insured Lottery Game (or such greater percentage as specified within the terms of the respective contract) arising in consequence of any negligent act, error or omission on the part of the Contractor and/or any of their Sub-Contractors or Manufacturers/Suppliers and/or Mechanical and/or electrical and/or electronic breakdown, failure or malfunctioning of any machinery, computer and/or peripheral equipment used in connection with the design, formulation, preparation and printing of any such Lottery Game and for which the Contractor and/or their Sub-Contractor or Supplier is responsible for printed and e version lotteries.

Insurers agree in addition to the foregoing to indemnify the insured for those increased costs incurred for which they are responsible in the procurement, validation, processing and distribution of such additional prizes and aforesaid,

provided always the Insurers' liability under this extension is to the cost of all additional prizes.

2. Further, it is understood and agreed that the Insurer's indemnify the insured for their liability assumed under the terms of their respective Contract(s) limited however for the purpose of this Policy to : the reimbursement to their Principal(s) of the cost of Lottery tickets supplied and/or the reimbursement to their Principal of their Principal's expenses, costs, commitments and cancellation charges sustained or incurred including increased costs necessarily incurred by their principal(s) directly in connection with such Lottery, other than legal costs and/or expenses.

Should any insured Lottery be cancelled, postponed, curtailed or abandoned due to any of the insured perils specified under (a) and/or (b) of 1 hereof or in the event of accidental physical destruction of/or damage to consignments of Lottery Tickets in whole or in part occurring prior to delivery as contracted.

Insurer agrees in addition to the foregoing to indemnify the Insured with respect to their own increased costs in reprinting or reproducing a Lottery in whole or in part together with other increased costs directly associated therewith where such increased costs are necessarily incurred in avoiding or limiting a loss under this Coverage. Subject always to the limit of indemnify under this extension not exceeding the amount of the loss, which would otherwise have been incurred

EXCLUSIONS

In respect of weekly draw lottery games, this Policy covers the Insured's assumed liability for the payment of all additional prizes to legitimate winners with respect to each such draws arising in consequence of erroneous duplication of any winning tickets having occurred and being discovered prior to the expiry of the permitted redemption period, subject otherwise to the terms, limitations and conditions of this Policy.

This insurance does not cover any claim or claims arising out of:

Any claim made against the Insured as a result of malicious, criminal or deliberate illegal acts of the Insured.
Any counterfeiting and/or forgery

The insolvency of the insured

Any legal liability of whatsoever nature directly or indirectly caused by or contributed to by or arising from

ionizing radiations or contamination by radioactivity from nuclear fuel or from any waste from the combustion of nuclear fuel the radioactive, toxic explosive or the hazardous properties of any explosive nuclear assembly or nuclear component thereof.

CONDITIONS

1. Immediate Notice of Loss

Upon the discovery of any event likely to give rise to a claim under this policy the insured shall as a condition precedent to their right to be indemnified under this insurance give immediate written notice thereof to the Insurance hereon.

2. Due Diligence

The insured shall use due diligence and do and concur in doing all things reasonably practicable to avoid or diminish any loss herein insured, it being understood and agreed that this policy extends to indemnify the insured for their ascertained net loss of additional out-of-pocket expenses and/or increased costs necessarily incurred by them to avoid or diminish any such loss provided however that in no circumstances shall the Insurers' maximum liability under this Policy exceed the stated Policy limit.
